LSCC's College Reach-Out Program sponsored a threeweek College Readiness Workshop, July 9th through 26th. CROP Coordinator



Darren Randall, along with teachers Shelia Lawson, Claudia Hook and Faye Valentine, offered the fifty middle school participants an educational and practical curriculum which included career planning, social studies, English, social skills and etiquette. The opening session featured guest speaker New York Giants team member Ron Dixon, who emphasized to the students the importance of a strong educational foundation.

Mr. Randall described the College Reach-Out Program (CROP) as a statewide program designed to further the Legislature's intent of increasing the number of students successfully completing a postsecondary education. The primary objective of the program is to strengthen the educational motivation and preparation of lowincome and educationally disadvantaged students in grades 6-12 who "otherwise would be unlikely to seek admission to a community college, state university, or independent postsecondary institution without special support and recruitment efforts." CROP recruits students and provides them with academic enrichment activities, as well as career and personal counseling. In addition to The College Readiness Program, designed for middle school students in grades 6-8, CROP offers four other comprehensive programs: The Bridges to Success Program, designed for high school graduating seniors. The Mentor/Mentee Program, designed for middle and high school students in grades 6-12, The Tutorial Program, designed for middle school students, grades 6-8, and The Academic Program, designed for middle and high school students in grades 6-12.



Question:

My co-worker, who is also my friend, tells me of inappropriate behavior on the

part of another co-worker towards her. I feel like I should do something to help my friend, but don't know what. I have advised her to file a complaint, but she feels her job will be jeopardized. Please tell me what my friend or I should do.

Answer: Encourage your friend to talk to her supervisor, or to Human Resources. Once management has knowledge of the situation, it has the obligation to act quickly by conducting an investigation. If the co-worker is found to have acted in a harassing manner towards your friend, the co-worker will be disciplined. Your friend does not have to worry about her job, because retaliation against employees for filing a complaint against illegal behavior is strictly forbidden.

AMERICA'S COMMUNITY COLLEGES



This year marks the 100th Anniversary of America's community colleges. The oldest continuously operating public community college was born of an experiment in Joliet, Illinois. In 1901, the Joliet Township School Board authorized its high school to offer postgraduate courses. The courses were so well attended

that in 1916 the postgraduate division was separated from the high school, and was formally renamed the Joliet Junior College. With a commitment to growth, enlightenment and equity, community colleges are a uniquely American innovation in education. As of 2001, our nation's 1,132 community colleges serve 10.4 million students, about half of all U.S. undergraduates.

Banner Premiers

Jane Miller reports that after eighteen months of hard and dedicated work by many LSCC staff members, the new software system, Banner is live for Financial Services, Financial Aid and Student Admissions/Records/Registration. Human Resources/Payroll. will go live January 1, 2002.

Staff training sessions have been held and most end users are familiar with the system; however, as Fall Registration approaches the learning curve will be very steep. We ask for everyone's patience as we navigate through the new system this fall.

Phase I of the Banner implementation will create few visible changes for students; however, Phase II which is web implementation will add many features that will enable students and staff to access a variety of informational needs via the Internet. Phase II is scheduled to be complete Summer 2002.

LSCC is one of several Florida community colleges who have chosen to convert to the Banner system. Others include: Florida Keys, South Florida, North Florida, Manatee, St. Johns River, Edison, Brevard, and Valencia.
