A NEW ERA IN EDUCATION

When Lake and Sumter County citizens rallied to create a Junior College in 1962, little did they know that it would grow into a three campus institution with over 2600 students annually. The past year could easily be considered the most exciting since its inception.

Plans have just been approved for the spectacular new 32,000 sq. ft. Health Sciences Center, made possible through the generous donation of an LSCC patron. Targeted for completion in the Fall of 2001, this state-of-the-art health care education facility will be an impressive addition to the 114 acre **Leesburg Campus**. In 1999, the site of tonight's ceremony was extensively remodeled and re-named the Everett A. Kelly Convocation Center. The Center continues its expansion with the current construction of the new banquet/meeting facility, The Magnolia Room, which will include modern teleconference technology and offer a much-needed facility for the college and the entire community. Our athletic program's softball and baseball teams enjoyed their second season on two recently-completed ball fields...part of the new sports complex which will also include tennis and racquetball courts, as well as an exercise path. Materials and labor for the complex's concessions/press building were graciously donated by ACCO.

LSCC's **Sumter Campus**, located in Sumterville, has already been playing an active role in its community since opening its doors in the Summer of 1995. The forty acre campus also recently expanded with the addition of the beautiful 16,000 sq. ft. Clark Maxwell, Jr. Library and Student Services Center. Formally dedicated on January 20, 2000, the building includes an 8,000 sq. ft. library, classrooms, offices and computer labs.

On September 20, 1999, the first student entered the new **South Lake Campus**. With the completion of the 25,000 sq. ft. Phase I building, the Clermont campus offers yet another exciting LSCC educational venue. Groundbreaking for Phase II, a 60,000 sq. ft. project, took place December 11, 1999, expanding the partnership with the University of Central Florida and giving area students more opportunities to earn four year degrees without having to leave their community.



THE COLLEGE MACE



The mace was an effective weapon in battle during the Middle Ages. As newer and more powerful military arms were developed, it was transformed into a symbol of authority.

The earliest ceremonial maces were carried by bodyguards of 12th century English and French kings. By the end of the 16th century, they were used widely by officials of English cities and towns. Today the ceremonial mace is found in the British Houses of Parliament and is carried in front of ecclesiastical processions and commencement ceremonies.

The Lake-Sumter Community College Mace was carried for the first time on May 14, 1993. The mace used today was designed and constructed by Wilson Sheppard of Sorrento and incorporates the Lake-Sumter Community College Seal.



THE PRESIDENTIAL MEDALLION



The Presidential Medallion is a symbol of academic leadership. It is worn by the College President at formal and ceremonial occasions. The Gold Medallion marks the President as a distinguished scholar, administrator and the highest officer of the College who strives to uphold the tenets established by the founders of the institution.

The medallion is embossed with the College Seal and is a visible reminder to each College community member to think and to strive to reach individual goals.

The President has been entrusted to maintain and develop an atmosphere where these creeds can be realized. The Presidential position represented by the medallion epitomizes the foundations and aspirations of the College which the President has pledged to uphold.

As the only College official who can formally award a degree, the President recognizes each graduate individually for meeting the standards of excellence set by the College and for reaching the point from which new ventures begin.



ACADEMIC REGALIA



The caps, gowns, and hoods worn at college and university functions date back to the Middle Ages. Monks and students wore them to keep warm in the damp and drafty halls of learning. Gradually, styles were adopted which were characteristic of the individual college and of the academic degree held by the wearer.

Students receiving an Associate degree wear a black gown with a semi-stiff yoke, long pleated front, and intricate shirring across the shoulder and back.

The gown for the Bachelor's degree is black, as are all gowns signifying advanced degrees. The bachelor's gown is usually worn closed and is distinguished by its long, pointed sleeves.

The holder of the Master's degree wears a gown with oblong sleeves, open at the wrist. The sleeve base is square cut with an arc in front.

Students receiving their Doctor's degree wear a gown with broad velvet panels down the front and three velvet bars on the full, round, open sleeves. This velvet trimming may be either black or the color distinctive of the degree.

The square "mortar board" cap, traditional for all degrees, may be of serge or broadcloth. For the Doctor's degree only, it may be of velvet and the tassel may be of gold bullion.

The hood gives color and meaning to the academic costume. The color lining of the hood indicates where the degree was earned and the color trimming indicates the discipline of the degree. Disciplines are represented by the following colors:
